

Southwell denies Bradshaw's Threats

Information from a reliable source, is to the effect that quite recently, Mr. Paul Southwell, Deputy Premier, who is now in London, was widely interviewed by a B.B.C. Commentator.

When question about Anguilla, Mr. Southwell maintained that Mafia elements were at work in the island. He said that American Mechanic Engineer Mr. Lewis Haskins, resident in the island, was manufacturing fire-arms; but he could not tell of what description neither

could he say who told him so. How then could he prove it? One of Haskins' sons was hurt on an old cannon, he said.

Mr. Southwell soon found himself in a position where he had to defend himself and Mr. Bradshaw. He denied that Mr. Bradshaw ever threatened, to put pepper in their soup and bones in their rice. He said it was fabricated by people who wanted to make Bradshaw's image a bad one and frighten those concerned.

It is alleged that the aforementioned threat to Nevisians and another one to "turn Anguilla into a desert" were both made at a public meeting at Warner Park in the late 1950's. However, it is only recently that both allegations have been denied.

In reply to a question,

Mr. Southwell told the Commen a or that his Bentley car and the Premier's Rolls Royce were both second hand and were bought out of their "meagre salaries for £750." The Commentator who seemed to have known better, inquired where he could get such second-hand vehicles for that price.

Asked about the International Commission of Jurists, Mr. Southwell said they were liars and gave as his reason that they were all lawyers and one could not expect anything else from them. He admitted that he himself denounced the Courts. This was when certain persons were set free by the High Court and Court of Appeal, and when the International Commission of Jurists condemned the attitude of the Government to the Courts.

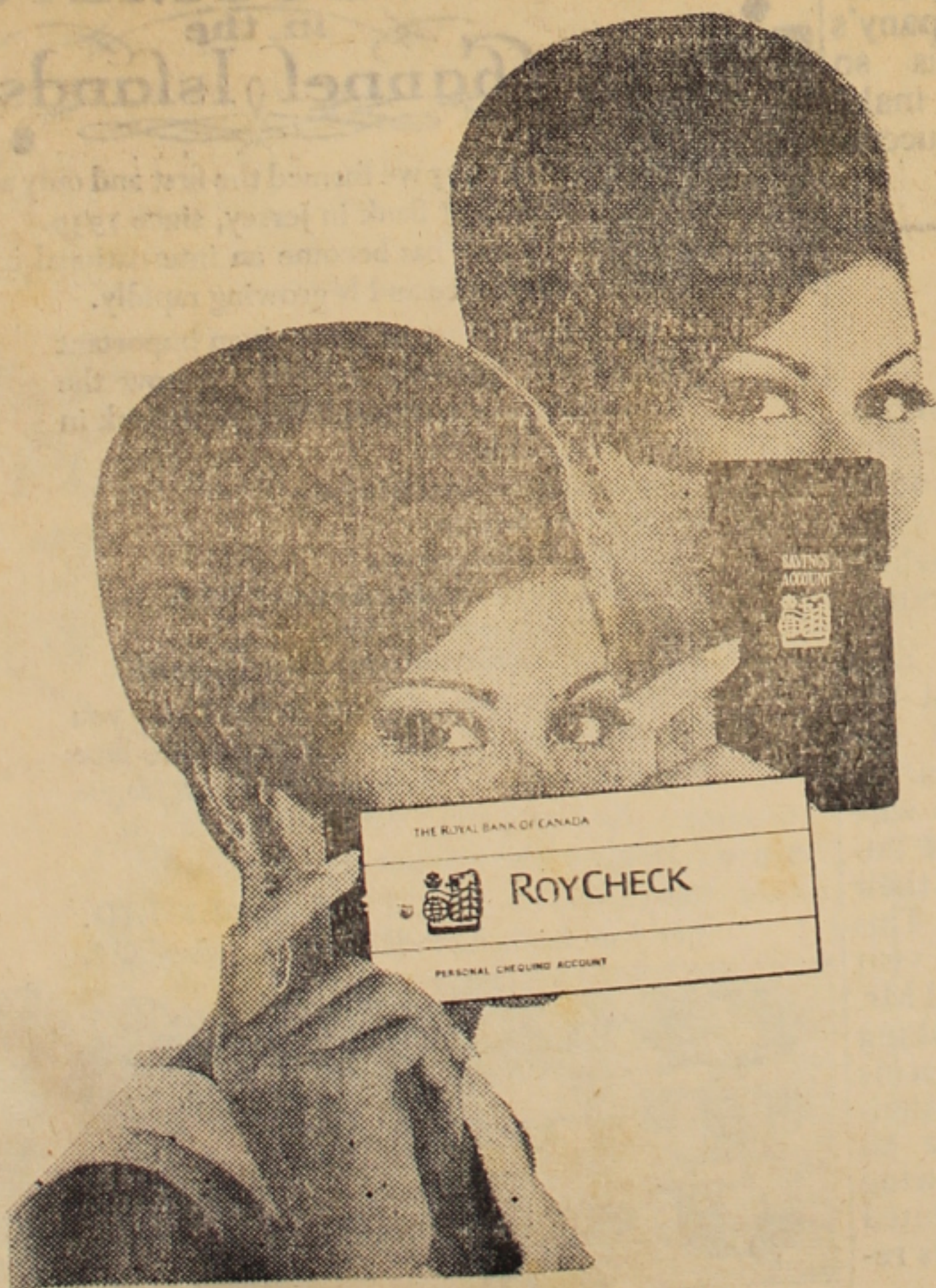
