## ANGUILLAN DETAINED FOR QUESTIONING ABOUT FIRE AT R.A.F. TENT

#### LETTER TO THE EDITOR:

## ON THE COMMISSION'S REPORT

(FOOD FOR THOUGHT)
by Son of the soil

Chapter 4, THE ANGUILLAN REVOLT Unrest is accelerated

From the inception of Statehood to the end of May 1967 there occurred Farrington area. a series of incidents creating unrest and turmoil in Anguilla. The evidence again fired at the police station. disclosed the following:

"Sir,

It is with regret that I have to bring to you a matter which is of prime importance and not without justification:

(1) People of Anguilla have no confidence in the Government of St. Kitts (2) Anguilla is treated like a very distant poor relation and is in effect a neglected Colony of St.Kitts; (3) Anguilla has been given proper Local Government to suit her geographical position seventy miles away from St.Kitts with several French and Dutch territories between them; (4) The Constitution is not being

### EDITORIAL:

#### IN QUEST OF A SOLUTION (NO.2)

Last week we put forward the idea of a referendum in Anguilla as part of a settlement deal, suggesting that much to ask that H.M.G. should find it might provide a "Face Saver" for Mr. Bradshaw. If he believes in the democracy he preaches, he surely cannot deny this truly democcatic way of finding out the winnes of Anguillans regarding their Euture.

This week, with talks between Mr. Bradshaw and H.M.G., going on in London, we look at another aspect of the problem, which if Mr. Bradshaw refuses to discuss anything in London except a solution as recommended by the Wooding Commission, (what we have heard so far, it is the Wooding Report that is being discussed presently by Mr. Bradshaw and the Poreign and Commonwealth Office) which the British Government already know is totally unacceptable to Anguillans. What if some Ministers in Landon decide that H.M.G. should pull out of Anguilla and leave the situation as it is; will that be the aswer to the problem ? It would be chaos not only in Anguilla but throughout the State, and would spread throughout the Commonwealth Caribbean. It would have a further reaching repercussion than fragmentation would bring; Instead of showing stability in the Caribbean it would be adding to the many problems that now

exist from here in Anguilla to the South in Trinidad. Britain would

still be legally responsible for Foreign Affairs and Defence of the two part"state" and if she sidn't want to be embarrassed by this, would probably shelve her responsibility by imposing independence on the "State"as a whole,

This would be less acceptable to the people of the other Caribbean islands, and would be damaging to British prestige, world reaction would condemn Britain for such a move,

The withdrawal of the British is no solution. It is surely not too some means of meeting the wishes of the Anguillans, whose loyalty to Her Majesty the Queen is unquestionable and who has been neglected in history, Who for no fault of their own have been kidnapped in the West Indies Act of 1967.

Our only desire is to be free from St.Kitts, and to receive continued protection and assistance from Britain, as is given to St. Kitts and many other islands who cannot at this time sustain independence.

A solution which we could accept would solve the problem finally. It would bring stability and peace to Anguilla and the whole region. It should also be welcomed by St. Kitts - Nevis, whose Government has more pressing problems than Anguilla to deal with at the moment, in the economic , social and political fields.

St. Kitts - Nevis Government will never be able to re-impose power in Anguilla so long as there is one Anguillan alive on the island.

The majority of Anguillans think that the only course open now is to work towards secession from St. Kitts for it appears that Nature herself did not design them to be together; they want to be able to decide their own future.

There was little primary evidence before us of the events 29 to 30 May, but from memoranda submitted we were able to record the account we set out below, 56. On 29 May Mr. Adams held a meeting at Burrowes Park (since renamed Ronald Webster Park) which was attended by about 300 persons. At the meeting a heated debate took place concerning the police in consequence of which the crowd was called upon to signify by show of hands whether the police should be asked to leave the following day. The hands went up. The crowd then moved from the park to the police station and Mr. Adams as spokesman gave notice to acting Assistant Superintendent Edgings, the officer in charge, that the police should leave the island by 10.am next day. 57. About 7 a.m. on 30 May a crowd began assembling autside the police station and became increasingly hostile as 10 o'clock approached. Shots were fired at the station. The airstrip was blocked by trucks and bulldozers. The police were unnerved. About 9,15 a.m. Acting Ass-

istant Superintendent Edgins stated that he was awaiting a plane from St. Kitts to take the police away,

At that point Mr. Ronald Webster, taking the initiative, procured a plane to take five men. Three left. At 12.20 p.m. Mr. Ronald Webster and Mr. Peter Adams announced that another plane was ready and demanded the departure of a further five, this time the crowd stipulated "no guns at all, they belong to us." The ammunition and rifles were sent by the Acting Assistant Superintendent to the airport in the police van and three of the policemen were instructed to take them to St, Kitts. But on arrival at the airport the policemen were surrounded by armed men who took away all the arms and ammunition, including an automatic rifle, and forced to enter the plane under duress.

State of semergency 58. On 30 May, 1967, following the expulsion of the police and the blocking of the airstrip the Government declared a state of emergency. All official communication between the two islands ceased; mail destined for Anguilla was detained in St.Kitts because no recognised official would be there to receive and deal with it, and there was a general embargo on all transactions involving finance. On the same day, the Premier sent telegrams to the Prime Ministers of Barbados, Guyana, Jamaica and Trinidad and Tobago and to the British Government requesting them to provide forces to help restore law and order in Anguilla.

First Anguilla delegation 59. On 31 May a delegation from Anguilla arrived in St.Kitts and was received by the Governor. The delegation comprised the Reverend Leonard Carty, an Anguillan who was at the time Chairman of the Methodist District of British Honduras; the Reverend Martin Roberts, a Methodist Minister from Dominica then stationed in Anguilla; Mr. Peter Adams and Mr. C.W.Fleming. Present also at the meeting were the Premier, the Deputy Premier and the Attorney - General,

A Tortola Cricket team visited Anguilla over the last weekend and took part in a two-day fixture against an Anguilla island eleven at Webster's Park Although the match anded in a tame draw it was or can be termed a personal triumph for the local youngsters despite a few fielding errors, and some slow batting. The final scores were Tortols Sa and 69 for 6 declared, Anguilla 28 and 20 for 4.

By the end of the first day the Anguillans were trailing Tortola's first lunings by only three runs with three wickets standing.
